2. Dhamana kwa muombaji ni dhamana ya zabuni kwa ahadi (Bid securing declaration)
3. Maombi yote yafungwe kwenye bahasha kwa lakiri na juu ya bahasha andika zabuni unayoomba na mtaa au kata unayoomba na yaelekezwe kwa **KATIBU WA BODI YA ZABUNI, HALMASHAURI YA MANISPAA YA ILEMELA, S.L.P 735 MWANZA.**
4. Mwombaji asiwe anadaiwa na Halmashauri, asiwe na historia ya kusababisha migogoro ya aina yeyote.
5. Mwombaji awe na uwezo wa kifedha na vifaa vya kukusanyia taka ngumu na ahakikishe kwamba vituo vyote vya kukusanyia taka ngumu ni visafi kipindi chote cha muda wa mkataba.
6. Ada ya maombi ya zabuni ni shilingi 100,000, fedha ambazo hazitarudishwa. Unapoleta maombi kumbuka kuweka stakabadhi uliyolipia ada ya uzabuni. Maombi yote yaambatishwe na picha mbili za passpoti size za hivi karibuni.
7. Mwisho wa kupokea maombi ni 13/06/2023 saa 6.00 mchana, Halmashauri hailazimiki kukubali au kukataa zabuni yoyote ambayo halkuzingatia sheria ya manunuzi ya umma Na 7 ya 2011 na kanuni zake GN 446 ya 2013 pamoja na marekebisho ya 2016.
